### **10. Bredon Community Hall.**

Due to the imminent sale of the Village Hall to the parish council, it was agreed for a management group to run the village hall, Bredon Community Hall Management Group. The group will consist of 4 parish councillors and 8 representatives from the users of the hall, in a similar way to the 'Village Hall Committee'. The Village Hall Committee has its AGM on the 18<sup>th</sup> November and the management group will resume responsibility from then. Any members of the existing committee will be asked to stay, Mr M Marshment the present Chairman has agreed to remain as chairman for six months. The parish council will draw up a constitution for the group and the present manager will be employed by the parish council. Cllr Frampton, on behalf of the council, thanked the Chairman for his relentless pursuit of this aim.

### **11. To Discuss The Letter From The Tennis Club.**

The council agreed to reply to the letter answering several points made; the letter sent in July was a polite note reminding the tennis club of the rent review in 2010. The present council is not aware of a document giving the tennis club the land for 'perpetuity' and request a copy of such document. The council accepts no responsibility for the damage incurred by tree roots. The council is willing to enter into a longer lease which will allow the club to apply for further grants, as it is the council intention to put the whole of the playing field in trust, to guarantee its future for the use of the parish.
